-There was a motion by Kathy Fulks and a 2<sup>nd</sup> by David Stephens to approve the minutes from the June meeting as presented. Motion passed.

### 22/23 Funding Guidelines Items Discussed:

**3:50 minute-mark-** Adding definitions for Virtual Classroom and Blended Classroom. There was a motion by Nanci Caillouet and a 2<sup>nd</sup> by David Stephens to add these definitions to the Funding Guidelines. Motion Passed.

**6:45 minute-mark-** Existing "30/30 Rule". There was a motion by Nanci Caillouet and a 2<sup>nd</sup> by Greg Aleshire to leave the "30/30 Rule" in the Funding Guidelines as it currently reads. Discussion followed. Heath Harris and Mary Beth Hatch had questions regarding this current rule. A roll-call vote was required. A yes vote is for and a no vote is against the motion.

Greg Aleshire – Yes Bill Allison – No Karen Breashears – Yes Nanci Caillouet – Yes Ed Carrington – Yes Kathy Fulks – Yes Heath Harris – No Mary Beth Hatch – No Bill Roachell – No Kelley Sharp – Yes David Stephens – Yes Motion Passes with seven in favor and four against.

**16:25 minute-mark-** Adding verbiage to match definitions regarding Virtual or Blended Training and adding Item #4. Kathy Fulks, David Stephens, and Nanci Caillouet asked questions regarding Item #4. There was a motion by Kathy Fulks and a 2<sup>nd</sup> by Bill Allison to approve these changes. Motion Passed.

**23:30 minute-mark-** Section 2, under the Budget heading, currently list nine criteria. Criteria #9 is a redundant. There was a motion by Kathy Fulks and a 2<sup>nd</sup> David Stephens to remove criteria #9 from the Funding Guidelines. Motion Passed.

30:40 minute-mark- Section 3 – Limitations for Grant Request, Curriculum: There was a motion by David Stephens and a 2<sup>nd</sup> by Kathy Fulks to set shipping and tax reimbursement rates at 75% to match the reimbursement rates for 2023 Electrical Code and 2018 Plumbing Code Books. Motion Passed.
2023 Electrical Code Books will be capped at \$140 overall cost and a reimbursement rate of \$105.

2018 Plumbing Code Books maximum cost allowed will be based off the International Code Council MOU.

**35:27 minute-mark-** Section 3- Limitations for Grant Request, Equipment: There was a motion by David Stephens and a 2<sup>nd</sup> Nanci Caillouet to add verbiage to Item #5 regarding hand tools. Motion Passed.

**38:00 minute-mark-** Instructor Training: Director Waits gave a brief description of the changes OSD were recommending. Kathy Fulks asked a question regarding additional expenses if a certified instructor was required. Karen Breashears asked if a line item could be added for instruction material cost. This verbiage was added. There was a motion by Kathy Fulks and a 2<sup>nd</sup> by Ed Carrington to approve these recommendations. Motion Passed.

**51:30 minute-mark-** There was a motion by Kathy Fulks and a 2<sup>nd</sup> by Nanci Caillouet to approve the 22/23 Funding Guidelines. Motion Passed. See Attached
