Meeting called to order at 12:33pm on March 3rd, by Chairwoman Breashears (via GoToMeeting)

Previous Month's Meeting Minutes:

-There was a motion by Kathy Fulks and a 2nd by Nanci Caillouet to approve the minutes from the January meeting as presented. Motion passed.

Andrew Parker and Bridget Patten- Be Pro Be Proud: Full discussion begins at 1:35 minute-mark

- -Mr. Parker gave a brief description of Be Pro Be Proud
- -The flyer for the Be Pro Be Proud Draft Day in Jonesboro on March 15th, is attached to these minutes.

U.S. DOL-OA, Mr. Prather reported:

These numbers are based on 10-1-21 start date

- -There has yet to be an announcement regarding the apprenticeship ambassador program. Mr. Prather will notify the committee once that announcement is made.
- -Programs are doing a great job of taking care of their overdue apprentices in Rapids.
- -A new program, a truck driving academy in Little Rock, came on board as of yesterday.
- -Chairwoman Breashears asked if he had any new standards of apprenticeship that were being reviewed at this time. Mr. Prather stated he did not, but that he is working with several programs to get their paperwork together to be submitted for review.
- -Mr. Daniels asked a question regarding a new residential wireman program. Mr. Prather and Chairwoman Breashears stated that it would be a new occupation to an existing program.

Mark McManus reported on: Begins at 28:56 minute-mark

- -USDOL has another registered apprenticeship focused grant opportunity. The application deadline is April 25th.
- -The Mountain Home School District is hosting a Career Expo, tomorrow. They are expecting around 1,500 students.
- -Currently working on a handbook for a state certified pre-apprenticeship program. Chairwoman Breashears asked if registered apprenticeship programs

will need this state certification to offer high school students actual high school credits. Mr. McManus stated no.

-The video made with ARPBS should be on OSD's website soon.

OSD-OA, Mr. Daniels reported on: Begins at 41:20 minute-mark

- -Cancellations from USDOL-OA. He has been in contact with Mr. Prather.
- -New database is working well, hoping to turn it over to a "test-schools" in a month and a half or so.
- -Programs are doing a good job of turning in their paperwork.

Programs Receiving Meeting Minutes:

Begins at 44:30 minute-mark

-There was a discussion regarding non-working email addresses that the meeting minutes have been being sent out to and the issues that was causing. Mr. Daniels will provide an up-to-date list.

Review of CT Applications:

Begins at 47:35 minute-mark

- -There was a discussion regarding the budget before the CT applications were reviewed.
- -CT-22-20257- there was a motion by Nanci Caillouet and a 2nd by Kathy Fulks to approve in the amount of \$2,053.01. Motion Passed.
- -CT-22-20258- there was a motion by David Stephens and a 2nd by Kathy Fulks to approve in the amount of \$378.00. Motion Passed.
- -CT-22-20259- there was a motion by Kathy Fulks and a 2nd by Nanci Caillouet to approve in the amount of \$159.80. Motion Passed.
- -CT-22-20260- there was a motion by Nanci Caillouet and a 2nd by Greg Aleshire it approve in the amount of \$587.09. Motion Passed.
- -CT-22-20261- there was a motion by David Stephens and a 2nd by Kathy Fulks to approve in the amount of \$1523.47. Motion Passed. Bill Roachell abstained.

-CT-22-20262- there was a motion by Kathy Fulks and a 2nd by David Stephens to approve in the amount of \$9,547.98. Motion Passed. Bill Roachell abstained. -CT-22-20263- there was a motion by Nanci Caillouet and a 2nd by David Stephens to approve in the amount of \$400.49. Motion Passed. Bill Roachell abstained. -CT-22-20264- there was a motion by Nanci Caillouet and a 2nd by Greg Aleshire to approve with a cap amount of \$10,000.00, based on receipts of \$5,000.00 for table and chair rental, \$2,500.00 for tent rental, and \$2,500.00 for social media advertising expenses. Motion Passed. Kathy Fulks abstained.

-Minute-mark 1:21:00 there was a discussion about the CT-application for the upcoming event in Northwest Arkansas that had been tabled during the February meeting.

-there was a motion by Greg Aleshire and a 2nd by Nanci Caillouet to let stand the \$10,000.00 amount, based on receipts for the event location, approved in the February Meeting. Motion Passed. Bill Roachell abstained.

-Minute-mark 1:25:10 discussion regarding the budget picked back up -there was a motion by Greg Aleshire and a 2nd by Kathy Fulks to transfer \$7,500.00 from the equipment and \$7,500.00 from the instructor training categories to the outreach and education category. Motion Passed.

Committee Member Appointments: Begins at 1:27:30 minute-mark

- -Director Waits stated that the law changed last year to make the board a more diverse representation of what apprenticeship looks like today.
- -OSD has made recommendations to the Governor's office as to how that should all unfold and unfortunately two of today's existing members would have to "roll off" and so that is what is taking place at this current time. This is the recommendation OSD has sent to Boards and Commissions. It is unclear where those recommendations stand at this time. Those decisions should be made by the end of this week or early next week.
- -The April meeting of the AACSC will be the first with the new "re-constituted" member make-up.

-Minute-mark 1:30:04 David Stephens asked what are the "new" categories. Director Waits listed the categories required under the new law.

-Minute-mark 1:31:20 Nanci Caillouet asked why do two current members have to be removed. Director Waits said because of the way it was "re-constituted" and listed other factors along with what he feels the intension of the law is.

-Minute-mark 1:32:27 Kathy Fulks asked under what Arkansas Code. Director Waits stated he did not know, but he would get that to her. Kathy Fulks asked if it was 25-16-804. Director Waits stated he was unsure. Kathy Fulks and Nanci Caillouet both stated they had that code in front of them and it stated someone could be removed for "good cause" but not for the reason stated by Director Waits. Director Waits stated that the role of OSD is to make recommendations the Governor's office.

-Minute-mark 1:33:34 Chairwoman Breashears stated that Boards and Commissions had been in contact with her in the last week. She gave a brief description of their conversations and, as they requested, provided Boards and Commissions with an accurate job description for each of the current AACSC board members and listed the possible categories that properly aligned with each of the current members occupations in strict accordance with the new law.

Other Business:

Begins at 1:39:15 minute-mark

- -Mr. Daniels stated that due to OSD requiring programs to submit one CT application per trade, should the programs be required to provide different invoices for different trades. Chairwoman Breashears stated that beginning with the April meeting, the committee would be reviewing the funding guidelines and that issue can/will be address at that time. Discussion continued.
- -Nanci Caillouet complimented Mr. Daniels on all of the hard work he has been doing.

Old Business:

Begins at 1:46:15

-Items that had been tabled during the February meeting can now be finalized.

National Park will add one instructor at 57 hours for a cost of \$2,109.00 Eagle Electric added two instructors at 72 hours for a cost of \$5,328.00 First Orion added two instructors at 160 hours for a cost of \$11,840.00

-there was a motion by Kelley Sharp and a 2nd by Greg Aleshire to approve \$19,277.00 to cover these additional instructors.

-FY21/22 TA budget is \$1,604,024.00 and thru January 2022 \$915,935.00 has been paid out.

-Greg Aleshire ask for clarification regarding setting board members if the Governor's Office does not contact them before the April meeting.

-Donna Lyon asked about the new on-line electrical licensing system and the issues she is having getting plumbing applications for people that had been convicted of a crime. Chairwoman Breashears stated that she is having the same issues with the electrical system and she has created a check-list for the plumbing applications.
