Most board members expressed concerns regarding the language in a few areas of the legislation at which point the director of the office of skill development stated that the language would be cleaned up, some items would possibly be edited out or added, and the draft would be sent back to the board members for review before a special called board meeting will be held to review the legislation before it is sent to the State Legislature.
